Astri Suhrke is a political scientist with broad experience in academic and applied research. She has worked on the social, political and humanitarian consequences of violent conflict, and strategies of response. More recently, she has focused on the politics of humanitarian policies in the UN system, concepts of human security and peacebuilding. She has led several research projects funded by the Research Council of Norway: The Multilateral Aid system (2001-03); Aid in Post-Conflict Situations (2003-05), and Violence in the Post-Conflict State (2005-08). She is currently working on strategies of post-war reconstruction and statebuilding, with particular reference to Afghanistan. Her most recent books are *When More is Less. The International Project in Afghanistan* (forthcoming 2011), *The Peace In Between: Post-War Violence and Peacebuilding* (co-edited anthology, forthcoming 2011) and *Roads to Reconciliation* (2005) (co-edited anthology).
