# Key Qualifications and experience

Social anthropologist with extensive experience from research, research management, teaching and consultancy work. Sørbø's professional profile and research interests include development policy and planning; conflict studies, peacebuilding and conflict management; social impact assessment (incl. resettlement); agricultural and pastoral systems; and regional analysis and economic adaptations.

Sørbø is an experienced team leader for policy-oriented reviews and evaluations, often with international participation and for many different clients. Before joining CMI as Director, he was Chair of the Department of Social Anthropology and the first Director of the Centre for Development Studies, University of Bergen. During his time at the University, he taught Social Anthropology at all levels and i.a. chaired the committee recommending the establishment of English language Master courses at the University of Bergen.

As a consultant, Sørbø led the first evaluation of a 'conflict NGO' (International Alert, 1997) as well as the first evaluation of Norwegian peace facilitation (in Sri Lanka), 2011.

He is a regular contributor to Norwegian newspapers on issues related to international development.

Sørbø was CMI's Director for 16 years (1994-2010). In 2006, an evaluation team concluded that CMI had become of one of the leading development research centres in Europe.
