Telle is a social anthropologist with long-term research experience in Indonesia since 1994, spanning various aspects of religion and religious change (Islam, Hinduism), including state management of religious minorities, secularism, blasphemy trials, and the politics of religious freedom.

Telle's research also deals with the upsurge of militias and civilian security groups in Indonesia since 1998, with a focus on policing, violence, vigilantism, insecurity, crime, and the interaction between state and non-state security providers. Other areas of expertise include: local justice, legal pluralism, and human rights.

Between 2012-2016 Telle served as the editor of the Norwegian Journal of Anthropology (Norsk Antropologisk Tidsskrift), with Annelin Eriksen, University of Bergen.
